- 4. In the "Create a New Project" section, enter the following information in proper case (not all caps):
 - a) <u>Research Institution</u>: This field defaults to the user's registered research institute. This cannot be changed.
 - b) <u>Title</u>: Enter the full study title, as it appears on the study protocol, followed by the study's acronym or short name, if applicable, in parentheses. The title in this field should match the title on the protocol, informed consent form, IRB Application, and ORA Research Review Application. If the title is not yet known, enter TBD (this can be changed once the title is known).
 - c) <u>First Name</u>: Enter the proper name (not a nickname) of the Principal Investigator followed by a middle initial, if applicable.
 - d) Last Name: Enter the last name of Principal Investigator.
 - e) <u>Degree</u>: Enter a single degree held by the Principal Investigator that most relates to the study (no periods).
 - f) <u>Keywords</u>: Enter the first and last names of the primary contact(s) for the IRB and ORA (no punctuation is necessary to separate the names). You may also enter any other names or words that may help you search for this study on the "My Projects" page.
 - g) <u>Sponsor:</u> Enter the name of the sponsor followed by the sponsor protocol number in parentheses, if applicable. For example:
 - For Industry sponsored trials, "Sponsor Name (SN1234567)"
 - For Grant Funded Studies, list the grantor and grant # if applicable, "NIH (NIH grant #)"
 - For Investigator-Initiated studies that are not funded, "Non-funded"
 - h) Internal Reference Number: Enter the Cost Center # of the department that is conducting/managing the study. If you do not have a Florida Hospital Cost Center #, enter the four-letter identification that has been assigned to your organization and was previously used as the last four characters of your FH project numbers.

2. Click "Share."

- Share Use this option if you wish to share your project with other Researchers, Committee Members, Administrators or Sponsors at your own institution or any other institution. For example, you may wish to share this project with other members of your research team so that you may collaborate in the design and development of the project, or with a selected Committee Member or Administrator to solicit feedback prior to submitting your project for review.
