- **I.** <u>SCOPE</u>: This standard operating procedure (SOP) applies to the Organization Official or designee.
- **II. <u>PURPOSE</u>:** This procedure establishes the process to deactivate an IRB. This procedure begins when the Organization Official has decided to deactivate an existing IRB. This procedure ends when the IRB has been removed.
- **III. <u><b>OUALIFIED PERSONNEL:**</u> A designee of the Organization Official carries out these procedures under the authority of the Organization Official.
- **IV. <u>TRAINING</u>**: Not applicable
- V. <u>SUPPLIES & EQUIPMENT</u>: Not applicable

#### VI. <u>PROCESS/PROCEDURE</u>:

- A. Ensure that no active protocols are under review by the IRB to be deactivated.
- B. For external IRBs:
  - 1. If an IRB Authorization Agreement is in place, follow the terms of that agreement.
  - 2. Update the roster of IRBs.
- C. For internal IRBs:
  - 1. Notify each IRB member. For each IRB member who will no longer serve as an IRB member prepare and send a thank you letter signed by the Organization Official.
  - 2. Update the IRB roster to indicate the IRB is deactivated.
  - 3. Unregister the IRB with OHRP at <u>http://ohrp.cit.nih.gov/efile/</u> within 30 days.
- VII. <u>DEFINITION(S)</u>: For capitalized terms not defined in this policy, refer to CW AHC 107 Definitions in Human Research.

For capitalized designations not defined in this policy, refer to CW AHC 103 Designations in Research.

For abbreviations not defined in this policy, refer to CW AHC 102 Abbreviations in Research.
